

Are all lead sheaths, armouring and conduits effectually bonded and earthed 7/10. Refrigerated chambers, are the cables and fittings as per Rule 7/10. Are all cables passing through decks and watertight bulkheads provided with deck tubes or watertight glands 7/10, where unarmoured cables pass through beams, etc., are the holes effectively bushed 7/10 and with what material Lead. Alternative Lighting, are the groups of lights in the engine and boiler rooms arranged as per Rule 7/10. Emergency Supply, state position 7/10 and method of control 7/10.

Navigation Lamps, are they separately wired 7/10 controlled by separate double pole switches 7/10 and fuses 7/10. Are the switches and fuses in a position accessible only to the officers on watch 7/10, is an automatic indicator fitted 7/10. Secondary Batteries, are they constructed and fitted as per Rule 7/10, are they adequately ventilated 7/10, what is the battery capacity in ampere hours 7/10.

Fittings, are all fittings on weather decks, in stokeholds and engine rooms and wherever exposed to drip or condensed moisture, weatherproof 7/10. Are fittings installed where readily combustible materials or inflammable or explosive dust or gases are likely to be present 7/10, if so, how are they protected 7/10 and where are the controlling switches fitted 7/10, are all fittings suitably ventilated 7/10.

are all fittings and accessories constructed and installed as per Rule 7/10. Searchlight Lamps, No. of 7/10, whether fixed or portable 7/10, are their fittings as per Rule 7/10. Heating and Cooking, is the general construction as per Rule 7/10. are the frames effectually earthed 7/10, are heaters in the accommodation of the convection type 7/10. Motors, are all motors constructed and installed as per Rule 7/10 and placed in well-ventilated compartments in which inflammable gases cannot accumulate and free from damage from water, steam and oil 7/10, if situated near unprotected combustible material state minimum distance from same horizontally 7/10 and vertically 7/10. Are motors coupled to oil fuel transfer and unit pressure pumps capable of being stopped from a position accessible in the event of fire in the pump compartment 7/10.

Have motors of 100 BHP and over been inspected by the Surveyors during manufacture and testing 7/10. Have certificates of test for motors under 100 BHP intended for essential services been supplied and the results found as per Rule 7/10. Control Gear and Resistances, are they constructed and fitted as per Rule 7/10. Lightning Conductors, where required are they fitted as per Rule 7/10. Ships carrying Oil having a Flash Point less than 150° F. Have all the special requirements of the Rules for such ships been complied with 7/10, are all types of the cartridge type 7/10 are they of an approved type 7/10. Are the fittings for pump rooms, tween deck spaces, etc., in accordance with the special requirements for such ships 7/10. Are the cables lead covered as per Rule 7/10. Spare Gear, if the vessel is for open sea service have spares been provided as per Rule 7/10, are they suitably stored in dry situations 7/10. Insulation Tests, has the insulation resistance of all circuits and apparatus been tested and found satisfactory 7/10.

The nearest cables to the compasses are as follows:—

A cable carrying *14* Ampères *on the* feet from standard compass *7* feet from steering compass.

A cable carrying *14* Ampères *7* feet from standard compass *on the* feet from steering compass.

A cable carrying Ampères feet from standard compass feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power *Yes*

Has the effect of switching on and off circuits, motors and other electro-magnetic apparatus within the vicinity of the compasses been noted *Yes*

The maximum deviation due to electric currents was found to be *Nil* degrees on *any* course in the case of the standard compass, and *Nil* degrees on *any* course in the case of the steering compass.
