We would refer to our favour of the 7th August last, and subsequent correspondence, when it was agreed that the Classification and Freeboard of the above ship should be extended until the end of the present month, having in view that we then understood the repairs to the M.S. "Kellia" would have been completed some time before that date.

A cable was recently received from our Superintendent at Suez advising us that due to the present difficult conditions at Suez he did not anticipate the "Kellia" repairs would be completed for some time, and we have cabled him to advise us the earliest he anticipates the "Kellia" would resume service.

As you are aware, it is our intention to withdraw the "Felania" from the present restricted service, as soon as the "Kellia" re-enters that service, but a cable today has been received, informing us that due to the uncertainty of the situation in Egypt, the completion date is obscure and it is essential for the "Felania" to continue in service for a further short period.

We shall therefore feel obliged also esteem it a favour if the Committee will be agreeable to the "Felania's" Classification and Freeboard Certificate being extended until, say the end of January, by which time we hope the position will have become more defined.


