I have surveyed the above-named ship in accordance with the Rules for **Damage stated to have occurred on 3rd. August, 1966 when it is alleged the ship touched the bottom whilst discharging cargo at this port.**

Now Done For Damage:- Ship examined on slipway and rudder found lifted up about 5 inches with bottom pintle unable to enter gudgeon bearing. (Please refer sketch 7 Instructions to Surveyors Part 2 A Amendment No.3). Rudder and rudder head removed from ship. Rudder head placed in lathe, found to be slightly bent and faired by heating. Coupling faces of rudder and rudder head cleaned up by light machining. On reshipping rudder and rudder head the assembly was found to swing freely, hard over to hard over. This can be considered a permanent repair.

Note:- The bottom shell was examined for grounding damage and no indication of damage found. The Owner's Agents stated that they did not require a fresh record of drydocking and wished the survey confined to the above damage. The Survey was therefore confined to the above damage.

I declare that the items detailed in this report (except as stated otherwise) comply with the requirements of the Merchant Shipping (Cargo Ship Construction and Survey) Rules 1965, applicable to this ship, and are in all respects satisfactory for the service on which the ship is intended to ply namely International voyages/voyages within the limits

(The above declaration applies only to sea-going cargo ships of 500 tons gross and above registered in the U.K.)

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. I recommend, therefore, that this ship remain as classed **///** without fresh record of dry docking.

Subject to any outstanding conditions of class being dealt with as previously recommended.
