I have surveyed the above-named ship in accordance with the Rules for Docking.

Ship placed in drydock. Bottom and rudder cleaned and examined minor leakages on bottom shell plating made good by caulking. No.1 plate in 5th below sheer port side fwd found slightly fractured at the heel of 3rd frame from fwd. Fracture veed out and welded and plate doubled for full extent and for full length. As a precautionary measure corresponding plate on Starbd. Side, doubled as in Port Side.

SR List No. 254. // stem previously removed.
Indented shell plates B5 & 6, C4 & 5 (ss from fwd) to be kept under observation.
Item examined and continues efficient.
