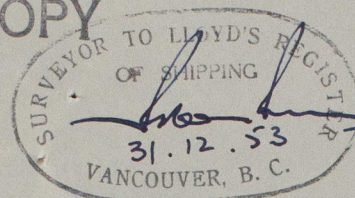

Should the Chain described herein be lost or destroyed, this Certificate is to be returned to the Secretary of Lloyd's Register, London, for the purpose of being cancelled.
