We herewith beg to acknowledge receipt of your letter of the 19th instant confirming the letter telegram (ELT) sent on the same date respecting the proposed alterations to the superstructure of the above vessel and note that we have to collect the sum of £ 1.1.10. cost of the message, and would add that the plans have not yet come to hand.

We have now to advise you that the Owners have decided not to proceed with the alterations for the time being and as they have chartered the vessel to leave on the 16th proximo we cabled you yesterday - a letter telegram - asking for the Report C 11 and fresh Freeboard Certificates with present markings to be sent out.
