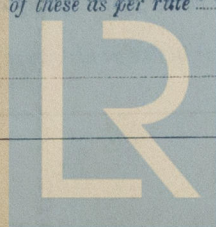

**Single Switch**  
Cables: Single, twin, concentric, or multicore are the cables insulated and protected as per Tables IV or V of the Rules **Yes**

**Fall of Pressure**, state maximum between bus bars and any point of the installation under maximum load **2 Volts**

**Cable Sockets and other connections**, are the ends of all cables having a sectional area of 0.04 square inch and above provided with soldering sockets **Yes**

**Paper Insulated Cables**, If cables are paper covered, is the dielectric at the exposed ends of the conductor protected from moisture by being suitably sealed with insulating compound **Yes**

**Cable Runs**, are the cables fixed as far as possible in accessible positions not exposed to drip or accumulation of water or oil, or to high temperature from boilers, steam pipes, uptakes or other hot objects, or to avoidable risk of mechanical damage **Yes**

**Support and Protection of Cables**, state how the cables are supported and protected **L.B.A.B. clipped L.C. in Tubing + V.I.R. in Tubing**

#### COMPASSES.

Distance between electric generators or motors and standard compass 100 FEET

Distance between electric generators or motors and steering compass 160 FEET.

The nearest cables to the compasses are as follows:—

A cable carrying 8 Amperes 25 feet from standard compass 15 feet from steering compass.

A cable carrying 10 Amperes 25 feet from standard compass 30 feet from steering compass.

A cable carrying Amperes feet from standard compass feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power. Yes

Has the effect of switching on and off circuits, motors and other electro-magnetic apparatus within the vicinity of the compasses been noted. Yes

The maximum deviation due to electric currents was found to be 6 degrees on any course in the case of the standard

compass, and 6 degrees on any course in the case of the steering compass.
