We are in receipt of your favour of 25th inst.,  
referring further to the above, for which we are obliged,  
and note that your Glasgow Surveyors maintain that their  
statements regarding the leakage at the front end bottom  
seams of both main boilers are quite correct.

In our previous letters we ourselves have stated that  
one or two rivets were leaking during the trial, but that  
we sent a Boilermaker to the Tyne and had all the rivets  
properly set up to ensure no further trouble, and this was  
done notwithstanding the fact that rivets were not leaking  
when we made our last inspection prior to leaving Vessel  
at Leith.
