We have to acknowledge receipt of your four letters of the 26th inst. contents of which have been duly noted and for which we thank you.

Sailing-vessel "SPEEDONIA". This vessel is expected at Rotterdam this afternoon and we would explain that she will be placed in the hands of the Rotterdam Drydock Co. for the purpose of converting her into a steamer. We shall be glad if you will kindly notify your Rotterdam representative accordingly.

M/V "DRENTE". This vessel will be in drydock at Singapore or Hongkong within the next week or 10 days and we have telegraphed to our Marine Superintendent, Singapore, requesting him to have the No.3 Special Survey carried out whilst the vessel is in drydock. *Now been vessel in dock at Singapore*

S/S "LAURELLEAF". This vessel is approaching the Persian Gulf where she will load for the U.K. or Continent and on arrival on this side she will be placed in drydock and the Special Survey No.1
