Dear Sir,

We have just completed an order for Anchors for Messrs Ropner and Sons, Stockton on Tees for their NO. "503." The collective weight of these Anchors, according to your rules should be $170\frac{1}{2}$ - 139 cwt. The Anchors we have made however come out 3 qrs 3 lbs light on the total weight.

We shall be glad to hear from you that this slight deficiency in weight will be accepted. We may say that we have had the greatest difficulty in completing this order for Ropners, as we are at Work on important Admiralty Work, and if this deficiency in weight is not accepted it will be three or four weeks before we can make a new Anchor to make up the weight, as we could not at present come off Admiralty work.

We feel sure under the circumstances, you will be kind enough to accept the Anchors.
